Are you considering installing solar panels?...

Pursuant of ARS 33-1816, ACC approval is required <u>prior</u> to the installation of solar panels. As a friendly reminder, it is the homeowner's responsibility to ensure an ACC application is submitted to the Committee and approval obtained before any work is carried out. Even if the vendor says they will prepare the ACC project application on your behalf, the homeowner must sign the application and submit it to the ACC. Be sure to follow-up with the management company to ensure request was received. Doing this ensures that you do not receive a fine for an "unauthorized improvement" or for "non-compliance" due to the panels not being placed appropriately.

When submitting an ACC request for solar panels, the proposed locations of the solar panels and all conduits, cables, boxes, etc., must be shown on the application. This information is usually provided to you by the solar company that is planning on doing the installation. You may attach copies of any drawings the company provides you to clarify the proposed design. Minimizing visibility from the street or other lots to the extent possible should be the primary consideration of the panel placement. All conduits, cables, boxes (including inverter), etc., must be painted to match the color of the house, trim, or roof behind them within 30 days of the solar panel installation. Additional concealment such as trees, shrubs, placement behind walls, colored panels, etc., may be required.

2024 Candidates and Election...

We have two (2) candidate volunteers running for a full term through AM 2025 and we encourage voting for both. You can meet them at the meeting and then vote in person rather than by absentee ballot if you prefer. They will join Amelia Cruz whose term ends AM 2024. This leaves 2 open seats (one through AM 2025 and one with a remaining portion through AM 2024) due to a lack of candidates, both must be filled by election rather than appointment.
